2015 Draft Budget - 2015 Draft Budget – your latest version of the budget is attached. f) This includes changes made at the last Council meeting and then actual for MSI Operating, School and Seniors requisitions, and then some minor adjustments after that. The Budget you see has a zero increase in municipal tax dollars collected, and currently has a surplus of **\$5,026.00** (this is basically because the MSI Operating revenue from the Province was increased from 4,542 to 10,431). We need to allocate these surplus funds somewhere, and as bylaw enforcement including dog control is an issue we are aware of I would suggest this be the first place we increase. Deputy Mayor Bigelow has checked with Morinville and their officers do not go outside municipal boundaries. I would suggest we look to the regional police service and have them come in (6 hrs/month is estimated at \$550/month which would include mileage so for the remaining 8 months of May to Dec. it would cost about \$4,400). If we wanted more than 6 hrs/month that may be attainable and we would pay accordingly (maybe we want a min. of 2 hrs/week or something). Others areas I suggest we revisit are the areas Council previously cut from: Physician Recruitment, East End Bus, Library, Recreation. Budget to be reviewed at meeting time.
