MGA sections 353-370.</p> <p>A penalty of 3% will be added to current taxes THE FIRST DAY OF EACH MONTH, beginning July 1, 2018. A 18% penalty will be assessed on JANUARY 1, 2019 on all outstanding balances. 1. Take your "Total Current Tax Levy 2018" and divide by 12.
 2. Submit 12 post dated cheques for June'18 to May'19 - include your roll nr. (office or mail)
 3. Mail to: Summer Village of Sandy Beach RR1 Site 1 Comp 63 Onoway AB T0E 1V0
 4. Cheques "the Summer Village of Sandy Beach" dated the **20th** of every month. We are trying to streamline deposits - Bank does not accept and deposit post dated cheques;
- Example in 2018 - June 30 is a Saturday and deposits cannot be made before July 3. If the 20th or 25th does not work - date your cheques the 30th - no problem.
 - If you are in arrears please pay the outstanding amount prior to June 30 to avoid a 3% penalty July 1.
