5.2 The Committee reviewed the FCSS Funding request from Shirley McGuaig and asked whether or not the applicant would be required to obtain liability insurance.

Jamie Kraley moved that the funding application presented by Shirley McGuaig be approved in the amount of \$336.00 and that if liability insurance is deemed a requirement, this motion to be amended to also include the actual cost of liability insurance.

5.3 Discussion of allocating the remaining 2019 FCSS funds for a seniors/disabled snow removal and/or lawn maintenance programme within the Summer Village, similar to the programme operating in the Town of Morinville.

It was discussed that FCSS set a rate of \$10.00 per property for removing snow from the apron of the property the resident would pay \$5.00. Additional snow removal, i.e., the full driveway, steps, etc., could then be negotiated between the resident and the contractor.

It was also discussed that resident eligibility would include being in possession of an Alberta Disability Tag, or being a senior, aged 55 years or older and/or a person who can demonstrate a medical or disability condition that prevents them from performing snow removal or lawn maintenance.

## **#12-19 MOTION**

Moved by Jamie Kraley that the FCSS Committee allocated the remaining 2018 funds in the amount of approximately \$4,000.00 towards a 2018/91 pilot project for snow removal and/or lawn maintenance services and seniors and persons with disability conditions.
