YRL is the 2nd oldest library board in the province.

TRAC system works with the Peace, Northern Lights, and Marigold regions. Not on the TRAC system are Parkland and 2 regions in southern Alberta although there are ways of accessing these systems, especially their on line services. You can access Edmonton and Calgary libraries by just registering with them on site. Also to access the University and other academic libraries you just register with the TAL system. All this info is covered on the YRL website. Note that Stoney Plain, Spruce Grove, St. Albert. and Morinville libraries can be accessed with your TRAC card.

Under the Provincial Government Libraries Act there is considerable local autonomy for local boards to create systems that work best in their regions.

97% of municipalities in the Province are members of one of the 7 regional library boards,

Grant monies from Province are for Staffing and building maintenance etc.. while monies from membership go to books, computers and online services.
