Deputy Mayors Report May 23 2019

Swirltex Presentation and Darwell/TriVillage lagoon Commissions April 26 2019

Swirltex presentation of a portable treatment system to reclaim water from lagoon systems. Business principal is to sell reclaimed water to industry (oil/gas) or agriculture. Unfortunately, system cannot remove higher salt levels, and is NOT very appropriate for use with evaporative lagoons. Due to public perceptions it would be unlikely that environment would approve any discharge of reclaimed water into standing water bodies ie. Lakes.

Sat in on Darwell and Tri Village lagoon Commissions. Both have serious concerns over several Vac trucking companies Not following proper procedures with regards to dumping product from outside allowed jurisdictions and bringing 2 trucks into dump on a single dump fee. They are reviewing their policies, considering very high fines and are continuing to use private investigators to monitor over the next several months. They take this very seriously.

Wild Water Annual April 27 2019

There is a commitment from governments to fund Phase 3 Seba to Entwhistle and Phase 4 Nakamun, Sandy/Sunrise and Alexander. Awaiting monies to be received.

Generating good income from truck fill stations and are considering moving administrative costs away from village budgets to operating revenue.

The truck fill station is part of the overall cost that is included in construction. It should be noted that these stations do not offer a 5 gallon jug fill. Village would be liable for any problems associated with a jug fill and would have to cover costs of pumps and metering. This would be costly. The system in use is based on a minimum 45 gal increment.
